I am directed to state that the Council of Architecture (COA), under the provisions of the Architects Act, 1972 and the Regulations framed thereunder, with the prior approval of the Central Government, is required to seek information from all authorities granting recognised qualification and inspect every institution imparting Architectural Education in India to oversee the maintenance of the Minimum Standards laid down by the Council of Architecture (COA) and to make its recommendation to the State/Central Government, as provided under Sections 18,19 and 20 of the Architects Act, 1972.

In this respect, the Executive Committee of the COA has decided that all those institutions which were inspected during the last two academic years i.e. 2003-2004 & 2004-2005 and due for inspection again during the academic session 2005-2006, may not be inspected though they are due for inspection. Further, the Executive Committee decided that these institutions be given one more year (i.e. for the academic session 2005-2006) recognition with their already existing intake, upon perusal of A, B & C Forms furnished by the institution and on satisfying that the institution has made progress since the last inspection done *(i.e. on March 07 & 08, 2003)*.

The forms A, B & C furnished by your institution has been perused and on the basis of the same, I am directed to state that the Executive Committee is pleased to accord *one more year recognition* to your institution as detailed below:
