- I am directed to state that on the basis of the recommendations made by the All India Board of Studies in Architecture & Town Planning, the All India Council for Technical Education (AICTE) has accorded approval to the Adhiyamaan College of Engineering at Hosur, Tamil Nadu for conducting a Bachelor of Architecture course during the academic year 1992-93 only with an annual intake of 40 (forty) subject to fulfillment of the following conditions:-
- The Management should complete the construction of separate building for the Architecture faculty before starting of the Second Year classes.
- The regulation, syllabus and examination system should 2) followed according to the latest standards for Architectural Education as laid down by the Council of Architecture(COA)/ AICTE.

The full time staff should be appointed as per 4) qualifications and experience laid down by the Council of Architecture/AICTE and the staff should be paid the AICTE pay scales. The Management should appoint practicing Architects as Visiting faculty from time to time.

- 5) The Management should have a separate budget provision for the course in Architecture and the budget is to be prepared under an Advisory Committee consisting of Architects and Educationists from the Architectural field
- 6) The Management including the Governing Council of the College should be constituted as per the AICTE guidelines and also the Chairman should be appointed as per the AICTE guidelines.
- 7) Admissions should be made as per the guidelines issued by the AICTE from time to time and no capitation or donation of any kind should be charged.
- 8) The tuition and other fees should be charged as prescribed by the State Government within the overall criteria prescribed by the AICTE from time to time.
- 7) The accounts of the Institution should be audited annually by a Charted Accountant and will be open for inspection by AICTE or COA or anybody authorised by it.
- 10) The College should not make adjustments in the approved annual intake of 40 (forty) without the prior approval of the AICTE.
- 11) No new course should be started in the faculty of Architecture or the College without the prior approval of the AICTE.
- 12) The admissions should be made only after the minimum requisite facilities are creat and the affiliating University has given permission to start the course.
- 13) The College should strictly follow any further conditions as may be laid down by the AICTE from time to time.
- 14) The Society should furnish duly registered general undertaking and specific undertaking on non-judicial stamp paper for fulfilling the various conditions laid down therein. by 31.8.1992.

In the event of non-compliance by the Trust or the Institute with the above conditions, the AICTE will be free to take, measures for the withdrawl of the approval without consideration of any related issues and that the consequent liabilities would be that of the Trust or of the Institute.

An Expert Committee of the All India Board of Studies in Architecture & Town Planning will visit the College before the end of the academic year 1992-93 to verify the fulfillment of conditions laid down by the AICTE and recommended for continuation of approval or otherwise.
