

CONDITIONS OF AFFILIATION

- Each and every one of the recommendations of the Inspection commission should be implemented;
- 2. The annual intake of students strength sanctioned for 1st Year of B.E. Degree course should not be exceeded as recommended by the AICTE;
- 3. The College should have permanent building and accommodation should be made available for proposed courses;
- 4. Library and Laboratory should be strengthened, as suggested by the commission;
- 5. The teachers appointed should not exceed the age of superannuation which may be prescribed by the University / State Government from time to time;
- Approval of qualification should be obtained from the University before appointing the teaching staff in the college.
- Necessary Hostel accommodation, staff quarters, play-ground are to be provided.
- 8. Arrangements should be made for the conduct of University examinations;
- 9. The courses should be conducted in accordance with the regulations and syllabi approved by the University from time to time;
- 10. No donations should be obtained from students seeking admission to any course of study in the college.
- 11. Excess admissions should never to made to any course over and above the sanctioned strength of the respective course(s);
- 12. The posts of Professor/Heads of Departments wherever required for the proposed course(s) should be filled up the before starting the course;
- 13. A Librarian, Physical Director/Directress and a Medical Officer with the prescribed qualification should be appointed;
- 14. Scales of pay and allowances prescribed from time to time by the Government of Tamil Nadu/AICTE or by the university, whichever is higher should be adopted by the Management for all categories of staff(Teaching and non-teaching) and furnish the details of their salaries to the University;

- 15. The college should collect tuition and other fees from the students at the rates as prescribed for Government colleges;
- 16. Suitable leave rules, generally in conformity with the state government rules should be framed;
- 17. If the conditions of provisional affiliation granted are not complied with, it will be automatically be enforced;
- 18. Such other conditions as may be prescribed from time to time by the University should also complied with;

I am to further inform you that provisional affiliation to the above said course(s) granted to your college, for the academic year 2001-2002 only and the same will not be extended further (i.e. for the academic year 2001-2002 until and unless all the above conditions are satisfied in full.
