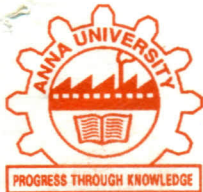

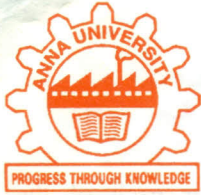

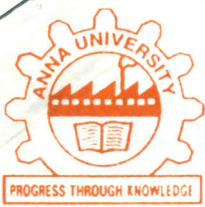

- ✓ 17. An inspection committee will visit your college to verify the compliance submitted, in September-October, 2003.

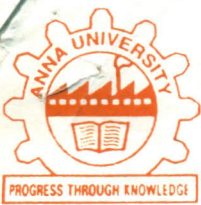


