The Affiliation at a stretch for a period of three years is granted without prejudice to the right of the University of requiring production of certificate required under Section 37-B of Tamil Nadu Land Reforms (LC) Act 1961 subject to the decision of the Hon'ble High Court of Madras in W.A.No. 3454 / 2002 batch and W.A.No. 3482 / 2002 batch.
