I am by direction, to inform you that provisional affiliation for the following course(s) has / have been granted to your college, for the academic year 1999-2000 only, subject to implementation of the recommendations of the Inspection Commission and also subject to the conditions of affiliation stipulated in this regard.

## CONDITIONS OF AFFILIATION

- 1. Each and every one of the recommendations of the Inspection commission should be implemented;
- 2. The maximum number of the students who may be admitted to each of the courses should not exceed the sanctioned strength;
- Library and Laboratory should be strengthened, as suggested by the commission;
- 4. The number of staff appointed for each course including allied and application oriented subjects should be as per the stipulations of the University.
- 5. The teachers appointed should not exceed the age of superannuation which may be prescribed by the University / State Government from time to time;
- 6. Approval of qualification should be obtained from the University before appointing the teaching staff in the college.
- 7. Necessary Hostel accommodation, staff quarters, play-ground are to be provided.
- 8. Arrangements should be made for the conduct of University examinations;
- 9. An agreement should be entered into with the teachers to be appointed as per the requirements of the University Tamilnadu private colleges (regulation) act, as applicable.

- No donations should be obtained from students seeking admission to any course of study in the college.
- 11. Excess admissions should never to made to any course over and above the sanctioned strength of the respective course(s);
- 12. It may also be noted that no further affiliation will be granted, if the management of the college, without valid reasons which shall be intimated to the syndicate well in advance, discontinues an existing course (either UG or PG) with an intention to start a fresh course;
- 13. The posts of Professor/Heads of Departments wherever required for the proposed course(s) should be filled up the before starting the course;
- 14. A Librarian, Physical Director/Directress and a Medical Officer with the prescribed qualification should be appointed;
- 15. Scales of pay and allowances prescribed from time to time by the Government of Tamil Nadu or by the university, whichever is higher should be adopted by the Management for all categories of staff;
- 16. The college should collect tuition and other fees from the students at the rates as prescribed for Government colleges;
- 17. Suitable leave rules, generally in conformity with the state government rules should be framed;
- 18. In the interest of standards of P.G. Education, the guidelines described by the University should be followed. The admission of P.G. Courses will be considered on the guidelines framed by the Syndicate from time to time;
- 19. The college should follow the guidelines prescribed by the University. The college should also follow the Modalities prescribed by the University for admission to the M.C.A. course such as Entrance Test, Weightage for such tests etc., and the procedure for admissions in the affiliated colleges of this University;
- 20. Such other conditions as may be prescribed from time to time by the University should also complied with:

## SPECIAL CONDITIONS OF THE INSPECTION COMMISSION

- 1. Atleast three teaching staff should be appointed for each course for every year.
- 2. One Professor may be appointed to head the department.

I am to inform you that provisional affiliation to the above said course(s) granted to your college, for the academic year 1999-2000 only and the same will not be extended further (i.e. for the academic year 2000-2001 until and unless all the above conditions are satisfied in full. If the conditions are not fulfilled by the end of the academic year 1999-2000, the provisional affiliation granted for the above said course(s) will cease automatically and will not be extended for the next academic year (i.e. for 2000-2001).
